## User Charter

*Final User Contract*

Users of Fire Water are required to adhere to this charter. Please return a signed and dated copy of this document to us, stamped with a company seal.

### Safety Instructions :

- Fire water is solely intended for fire juggling and must be used by specialist professionals of this discipline (juggling performed with equipment specially designed for this purpose: balls torches diabolos etc.) Any other uses of this product are at the entire risk of the user.
- This product was designed for uses other than those related to the Circus Arts. In the event of an accident please refer to the accompanying safety instructions.
- Do not juggle in an enclosed space, nor close to flammable materials.
- Anticipate the possible hazards that could result from smoke.
- Wear suitable clothing and protect your hair.
- Fire water is a dangerous , volatile and flammable product.
  - Always keep a form of fire extinguisher nearby, which is both visible and accessible to everybody.
  - Keep Fire Water out of the reach of children and away from those who are unaware of its specific use and dangerous nature.
  - Fire water should always be stocked in a protected, cool and ventilated place.
  - Always close the container properly after use. Do not leave the container open as the fumes emitted are poisonous. Always use a suitable recipient clearly labelled with its contents, safety instructions and a warning of the dangerous characteristics of the product
- The use of this product in the presence of an audience presents many dangers. Always perform or practice a safe distance away from others. Mark out an area inaccessible to spectators or passers by.
- Anticipate any possible risks before commencing a performance
- Take out a suitable insurance policy
